This Amendment No. 2 to Schedule 13D amends and supplements the Schedule 13D filed by the Reporting Persons with respect to the Common Stock, par value \$0.04 per share (“Common Stock”), of Contango Oil & Gas Company (the “Issuer”). Except as set forth below, all previous Items remain unchanged. Capitalized terms used herein but not defined herein shall have the meanings given to them in the Schedule 13D, as amended, filed with the Securities and Exchange Commission. Each of the Reporting Persons hereby expressly disclaims membership in a “group” under the Securities Exchange Act of 1934 with respect to the securities reported herein, and this Schedule 13D shall not be deemed to be an admission that any such Reporting Person is a member of such a group. Each of the Reporting Persons hereby expressly disclaims beneficial ownership of the securities reported herein, other than to the extent of its pecuniary interest therein, and this Schedule 13D shall not be deemed to be an admission that any such Reporting Person is the beneficial owner of the securities reported herein for purposes of the Securities Exchange Act of 1934 or for any other purpose.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby supplemented as follows:

LIP acquired an additional 960,000 shares of Common Stock for a purchase price of \$2,400,000 using working capital. LIP2 acquired an additional 40,000 shares of Common Stock for a purchase price of \$100,000 using working capital. J. Luther King, Jr. acquired an additional 21,800 shares of Common Stock for an aggregate purchase price of approximately \$68,000 using personal funds.

Item 5. Interest in Securities of the Issuer

Item 5 is hereby amended and restated in its entirety as follows:

(a) As of December 20, 2019, the Reporting Persons may be deemed to beneficially own 5,590,594 shares of Common Stock (which represents approximately 5.2% of the outstanding Common Stock based upon information contained in the Issuer’s Form 10-Q filed with the Securities and Exchange Commission on November 12, 2019 plus 19,000,000 shares of Common Stock issued by the Issuer in a private offering on December 20, 2019).

Luther King, Jr. acquired 5,000 shares of Common Stock at a purchase price of approximately \$3.76 per share in open market transactions, (iv) LIP acquired 960,000 shares of Common Stock at a purchase price of \$2.50 per share in a private offering conducted by the Issuer, and (v) LIP2 acquired 40,000 shares of Common Stock at a purchase price of \$2.50 per share in a private offering conducted by the Issuer.

Item 6 is hereby supplemented as follows:

Each of LIP and LIP2 entered into a Purchase Agreement and a Registration Rights Agreement with the Issuer, pursuant to which LIP and LIP2 acquired 960,000 and 40,000 shares of Common Stock, respectively, from the Issuer in a private offering at a purchase price of \$2.50 per share. The terms and provisions of the Purchase Agreement and the Registration Rights Agreement are incorporated herein by reference to Exhibit 3 and Exhibit 4 hereof.
